NOTICE TO BIDDERS / INVITATION TO BID

1. Notice is hereby given that the governing board (“Board”) of the **Hayward Area Recreation and Park District** (“District”) will receive sealed bids for the following project:

BID 25-104 MT. EDEN RENOVATION (“Project” or “Contract”)

The scope of work includes, The scope of work includes, but is not limited to, site demolition, site grading, concrete and asphalt pavement, court surfacing, fitness court installation site furnishings, electrical service upgrade, sports field and court lighting, minor planting and irrigation, and associated work as shown on the plans. Project includes restoration of lawn or landscaped surfaces, and irrigation affected by construction.

- A. Construction Estimate: \$3,000,000
- B. Construction Duration: 270 consecutive calendar days (9 Months)

2. To bid on this Project, the Bidder is required to possess one or more of the following State of California Contractor Licenses:

A – General Construction

The Bidder's license(s) must be active and in good standing at the time of the bid opening and must remain so throughout the term of the Contract.

Contract Documents may also be available from other sources, such as builders’ exchanges, by their members. However, all bidders, regardless of source for bid documents, **must notify** East Bay Blueprint & Supply Co., via above email, to be listed as a plan holder. Only plan holders listed on the official Plan Holders List, maintained by the East Bay Blueprint & Supply Co., on behalf of the Hayward Area Recreation and Park District, will be eligible to submit bids.

A mandatory, in-person pre-bid conference will be held on **October 2, 2025, 10:00am PST**, at Mt. Eden Park, 2451 W. Tennyson Road, Hayward, CA 94545. All participants are required to sign in at the pre-bid conference. The conference is expected to take approximately one hour. Failure to attend or tardiness will render bid ineligible.

Last opportunity to submit questions will be **October 10, 2025, at 5:00 p.m.** Questions shall be addressed to all bidders via Addendum. The addendum will be posted before **October 17, 2025, at 5:00 p.m.**

5. **Sealed Electronic Bids will be received until 2 p.m. on Friday, October 24 , 2025,** VIA EMAIL at:

at or after which time the bids will be opened and publicly read aloud. Any claim by a bidder of error in its bid must be made in compliance with section 5100 et seq. of the Public Contract Code. Any bid that is submitted after this time shall be non-responsive and returned to the bidder.

Top three apparent bidders shall have three (3) days from Bid Opening to deliver required wet-signed materials to the District Office, located at 1099 E Street, Hayward, CA 94541.

6. All required components of a traditional, physical submission are also required in a successful electronic submission.

Maximum size of electronic submittal is 20MB. If electronic package is larger than maximum size, Bidder is responsible to deliver a download link before deadline, wherein required submittal materials can be successfully downloaded. Bidder is responsible for the successful download of all material.

7. Each Bidder will receive a confirmation that the submission has been received. However, no review or examination can occur until after the posted Bid Due Date and Time.
8. All bids shall be on the form provided by the District. Each bid must conform and be responsive to all pertinent Contract Documents, including, but not limited to, the Instructions to Bidders.
9. **A public “virtual opening” of the timely submitted bids will occur online.**

A bidder’s inability to successfully connect to this broadcast shall not suffice as basis for a protest.

10. As security for its Bid, each bidder shall provide with its Bid form

- a bid bond issued by an admitted surety insurer on the form provided by the District,

- cash, or
- a cashier's check or a certified check, drawn to the order of the **Hayward Area Recreation and Park District**,

in the amount of ten percent (10%) of the total bid price. This bid security shall be a guarantee that the Bidder shall, within seven (7) calendar days after the date of the Notice of Award, enter into a contract with the District for the performance of the services as stipulated in the bid.

11. The successful Bidder shall be required to furnish a 100% Performance Bond and a 100% Payment Bond if it is awarded the contract for the Project.
12. The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.
13. The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are on file with the District and are available to any interested party on request or at www.dir.ca.gov/oprl/statistics_and_databases.html. Bidders and Bidders' subcontractors shall comply with the registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.
14. The District's Board reserves the right to reject any and all bids and/or waive any irregularity in any bid received. If the District awards the Contract, the security of unsuccessful bidder(s) shall be returned within sixty (60) days from the time the award is made. Unless otherwise required by law, no bidder may withdraw its bid for ninety (90) days after the date of the bid opening.
15. The District shall award the Contract, if it awards it at all, to the lowest responsive responsible bidder based on

The base bid plus additive alternate #1.
