Facility Fees

Classification of Groups – To provide for public leisure activities in the best interests of the community at large, the

recreation facility will normally be administered in accordance with the following priorities:

- A. Priority I - Programs administered and operated by the Hayward Area Recreation and Park District
- B. Priority II - City, county, state and federal governments, including local school districts when the use is for recreation, cultural or educational purposes. Rental Contract issued to government agency.
- C. Priority III - Resident non-profit service and community organizations having unrestricted membership, whose scope and purpose are recognized primarily as a service to the residents of the Hayward Area Recreation and Park District and whose membership is at least 50% District residents. Verification of nonprofit status required.
- D. Priority IV – Within the geographic boundaries of the Hayward Area Recreation and Park District– residents, private groups or organizations which may include, but not necessarily be limited to, closed membership clubs, fraternal orders and service clubs; also includes invitational affairs, organizations that vote in membership. District residency verification required.
- E. Priority V – Within the geographic boundaries of the Hayward Area Recreation and Park District - Businesses or commercial use. Any type of commercial venture usage which does not fall into any of the above classifications.
- F. Priority VI - Non-resident individuals or groups with less than 50% of their membership in attendance residing within the boundaries of the Recreation and Park District.
